CANCELLATION AND REFUND POLICY

- A. All cancellations shall be received by the trip director in writing before the departure date.*
- B. A minimum cancellation fee of \$25.00 shall be assessed regardless of cancellation date.*
- C. Cancellation costs shall be assessed depending on the date of cancellation and the expenses incurred by the club.*
- D. Refunds shall not be made until after the conclusion of the trip, and all expenses from the trip have been paid.*
- E. This cancellation policy is valid when the club either is or is not using the assistance of a travel agency. Also, trips booked through the Windsor Ski Club shall be subject to all contract conditions agreed upon by the club.*
- F. All cheques that must be reprocessed by the Windsor Ski Club shall be assessed according to the fee charged by the bank, plus a \$10.00 administration fee.*
