CANCELLATION AND REFUND POLICY

- A. Cancellation costs shall be assessed depending on the date of cancellation and the expenses incurred by the club and shall not be made until after the conclusion of the trip, and all expenses from the trip have been paid.

- B. The Board shall have the authority to cancel, rescind, cause forfeiture of or otherwise restrict the membership of any member considered not in "good standing". This includes behavior that affects another member's ability to fully participate in club activities or which negatively impacts the club. Any member that contributes to or engages in unacceptable, unlawful or other behavior unbecoming to the club or its members could be subject to removal of membership including any scheduled trips.

- C. All cheques that must be reprocessed by the Windsor Ski Club shall be assessed according to the fee charged by the bank, plus a \$5.00 administration fee.
